The membership parade at Convention was enjoyed by all with lots of laughs and excitement as the chairmen shared the accomplishments of the Units around the state. Awards, letters and certificates were handed out to the Units. Those Units reaching various membership goals since Fall Conference anxiously awaited the drawing for the "Big Bucks." The Division percentages were extremely close this year with only 1.4 percent dividing the four divisions. The Districts were also very close in percentages. District 13 lost their challenge to District 14 by a mere 0.01 percent. Fifteen of our 16 Districts reached over 83 percent of their goal by July 7, 2017. Thank you to every member who paid dues and worked hard recruiting and retaining members.

15 won the drawing.


• 30 Units reached 102 percent of their 2016 membership by 3-15-2017. Hamilton Unit 285 - District

#### **AMERICANISM REPORT**

The Department of Missouri ALA Units have worked hard to show their respective communities "Who We Are  $\sim$  What We Do  $\sim$  Why It Matters" across the state. Reports were received from nine of the 16 Districts.

There were 15 units that participated in a Flag Education Program. Six units reported presenting a program to elementary students at local schools, other units reported presenting a flag etiquette program, assisting with proper flag disposal, and assisting with a flag folding ceremony. Units also reported they attended 12 events to support the American Flag. One unit had a member attend the Washington, D.C. Conference to speak to legislators about the passage of the Flag Amendment. One unit participated in the "Get Out and Vote" program. Five units participated in the Pocket Flag project with the Junior members folding many flags that were sent to deployed troops. There were 69 flags and 50 letters or certificates of recognition presented. There were 393 entries in the Americanism Essay Contest. Unit meetings began with saying the Pledge of Allegiance and singing the national anthem. POW/MIAs were also honored at meetings and other events. One unit honored veterans and active military with a red, white and blue Christmas tree at the post home. One unit purchased 75 flags to be flown in their community.

Units across the state reported participating in many of The American Legion programs. Two units reported they assisted with the American Legion Baseball with donations and working concession stands. Six units participated in the Oratorical Contest with many auxiliary members helping at various levels of the contest. County Government Day was hosted by 14 units for 331 students from 17 schools. There were 37 Auxiliary members, 27 Legionnaires, 22 teachers and 62 county officials who attended these County Government Day activities. Units also reported assisting the Legionnaires with many patriotic ceremonies. Two units helped with collecting unserviceable flags and helped with flag disposal ceremonies. Ten units helped with Memorial Day activities by singing at the Memorial services, providing refreshments, lunch and transportation to the cemeteries. One unit participated in the "2 Bell Ceremony" at the National Ceremony. Three units participated in Flag Day activities. Four units participated in Independence Day activities in conjunction with their Legion Posts. Nine units assisted the Legionnaires with Veterans Day programs held at schools, Legion Posts, churches, community parades and celebrations. Two units helped with the Vietnam Memorial Wall.

The total estimated hours of volunteer time toward Americanism projects was 630 hours. The total estimated cost was \$3,000. The estimated number of veterans served was 900.

The Department of Missouri's American Legion Auxiliary with its dedicated Auxiliary members serving as representatives in 14 facilities, seven Missouri Veterans' Homes along with seven Veterans Administration Medical Centers, including one VAMC in Fayetteville, Arkansas, and another VAMC in Leavenworth, Kansas. Missouri's American Legion Auxiliary Veterans Affairs and Rehabilitation homes

and hospital representatives, in service to veterans, report the following volunteers and hours for April 2016 through March 2017.

Monthly reports logged in a total of two thousand, seven hundred forty-two (2,742) American Legion Auxiliary regularly scheduled volunteers for five thousand, three hundred eighty (5,380) volunteer hours worked. These reports also included one hundred seventyseven (177) occasional volunteers working nine hundred thirty-two (932) hours. Total volunteers reported were two thousand, nine hundred nineteen (2,919) logging six thousand, three hundred twelve (6,312) volunteer hours. During the reporting period of April 2016 through March 2017 Missouri Auxiliary Veterans Homes and Veterans Administration Medical Centers reported receiving monetary donation of twenty thousand, seven hundred fifty-four dollars (\$20,754).

The month of December found Missouri's American Legion Auxiliary members busy planning for and volunteering at the annual Christmas Gift Shops held at the 14 VA facilities. The appointed representative and her merry hand of volunteers used a form for residents to list family members they wished to provide a gift for, listing age, relationship and clothing size prior to their Christmas Gift Shop to assist shoppers in acquiring items requested. Facilities reported contacting local merchants for assistance when items requested or the appropriate size was not available for the veterans. At several VA facilities the volunteers made lists of the items the veterans needed or wanted prior to shopping for the gift shop. This made it easier to meet the needs of the veterans and the selection process went more smoothly on the day of the gift shop. The Jefferson Barracks representative in St. Louis stated food and gifts were delivered to all buildings with many hugs, some tears and smiles all around. At the Harry S. Truman Veterans Administration Medical Center in Columbia, Missouri, gifts, along with handmade Christmas cards from the elementary school children of Cole Camp, Missouri, were distributed. Items not distributed at this Christmas Gift Shop were left at the facility to be handed out by volunteers on Christmas Day. All Gift Shops reported opening the day with prayer and the Pledge of Allegiance to the American Flag. Along with the annual Christmas Gift Shops many units visited local residential care facilities distributing treats and Christmas cards.

Missouri's Auxiliary members' service to veterans does not end with the Christmas Gift Shops but is evidenced throughout the state of Missouri in many forms. Cookies and goody bags were presented to veterans in area nursing homes, as well as the Veterans Homes and Veterans Administration Medical Centers. Programs, ceremonies and remembrances are held on Veterans Day, Memorial Day and Pearl Harbor Day. Thousands of American Flags are placed on veterans' grave sites on Memorial Day. Units also reported assisting Legionaires with Memorial Day services by singing during the Memorial Day service, helping Legionaires post large American Flags along the cemetery entrances, presenting the military flags during the ceremonies and providing dinner for those participating in the services. Many Auxiliary Units provided funding and assistance with the Wreaths Across American Program, along with the Creative Arts Festival held annually at Jefferson Barracks in St. Louis, Missouri. Care packages are prepared and shipped to deployed servicemen and -women. Welcome Homes and Stand Downs are held statewide. Unit 114 assisted the Post with a fundraiser to raise money for a local Missouri Veterans Cemetery. They held a poker run and barbecue cook-off, raising \$20,000 to help provide the cemetery with amenities and non-budgeted improvements. The same Unit held a benefit dinner and auction to help a veteran with medical expenses and living expenses after he fell from a building. Missouri Auxiliary members have no shortage of talented seamstresses who reported making and contributing lap robes, ditty bags, bibs, wheelchair bags and blanket rolls for homeless veterans.

The Department of Missouri's American Legion Auxiliary volunteers continue to effortlessly and tirelessly answer the call of service to veterans, assisting when and where needed; providing not only monetary and physical support but that much needed personal contact. Missouri Auxiliary Units have certainly shown their communities "Who We Are" ~ "What We Do" and "Why It Matters" across the state.
