Grassroots Alert: ACTION TO SUPPORT VETERANS EXPOSED TO TOXIC WASTE. Honoring our PACT Act H.R. 3967 The exposure of military personnel to toxic waste substances, both while deployed overseas or stationed home has been an ongoing issue across a range of wars and generations. These exposures have resulted in conditions and illnesses among veterans which can have long-lasting effects on health and quality of life. The American Legion has fought an ongoing struggle for service-connected disability benefits for adverse health conditions linked to exposure from various toxic substances. It took decades for VA to provide relief for veterans of Vietnam exposed to Agent Orange.

The U.S. Government still has yet to finish its work for Vietnam veterans, and we have begun the cycle anew with the current generation of service members who served in Iraq and Afghanistan. Millions of service members have been deployed in the Global War on Terrorism, and a disturbingly high percentage of them have been exposed to toxic hazards during their service, from burn pits in Iraq and Afghanistan to radiation exposures at Karshi-Khanabad (K2) in Uzbekistan. Yet, VA has not conducted sufficient studies to determine illnesses and diseases related to various types of toxic chemicals, nor has it begun to develop a list of presumptive

This is our last published Membership Report before the Department Convention in July. Our membership started off very good and continues to be so until Presidents, Units, Districts now. and Membership chairmen you have done your best. Marybeth and I have communicated with you and we know how hard you have worked.

As of April 6, 2022 the Department has 87.69% of our goal. The Department goal is 9,095 (we have 7,552 senior members and 723 junior members) for a total of 7,975. On the Division level, the Southwest Division is in 1st place at this writing with 88.61%, the Northwest Division is in 2nd place with 88.60%. Lookout Southwest Division, they are right behind. On the District level, the 5th District is in 1st place with 92.83%, the 10th District is in 2nd place with 91.93%. On the Unit level, Unit 322 Webb City is in 1st place with 150%, Unit 388 O'Fallon is in 2nd place with 128.57. It is sad to report that we still have 4 goose egg Units in the Department. We have to work harder to get the Units on track.

last deadline date was March 23, 2022. Our Department challenge is with Ohio. On that date the Department of Ohio Membership was 89.11%, the Department of Missouri Membership was 85.98%. Therefore, we fell below them. The next Central Division deadline is to reach 95+% by May 15, 2022. We can do it, let us go for it. The last Department of Missouri

Award is the Military Award. Units reaching 125% of your Membership goal by May 15, 2022 will get an Award. I am looking forward to giving out a lot of Certificates and Awards at the Convention. We still need all ships and planes to reach their destination.

• Phone between visits.

• Learn the veteran's interests; find out if he/she is interested in computers or the Internet.

· Bring public library books or movies or teach the veteran how to download audiobooks.

• Rent video movies of interest. · Ask to see photos in family photo albums.

rary housing, payment of security deposits and utility bills, and gift cards for food and clothing for families.

· Raising funds for VA Healthcare for Homeless Veterans facilities by hosting events such as dinners and bake sales.

• Providing money and in-kind services to support Stand Downs with The American Legion Family.

• Preparing "Buddy Baskets" for homeless veterans moving into permanent housing. These baskets contain basic household items, including cleaning supplies, bathroom tissue, kitchenware and light bulbs.

· Filling and delivering backpacks containing basic daily needs to homeless veterans in shelters.

• Distributing small bags with basic items to homeless veterans. These items include washcloths, socks, soap, shampoo, toothbrushes and toothpaste.

• Working with the Legion to renovate homes and supply furnishings for homeless veterans.

A recent newsletter from National included two opportunities for members to serve our veterans. The first opportunity is called Compassionate Contact Corps (CCC). Compassionate Contact Corps was created to combat loneliness and isolation during the pandemic veterans and caregivers are provided telesupport through the award-winning CCC program. The other program, Volunteer In-Home Visitor Program (VIVP), was also created to assist veterans and volunteers during the pandemic and geared toward the volunteer who wishes to work in his/her local community to visit with a Veteran in their home. Any American Legion Auxiliary member interested in becoming CCC or VIVP volunteers can obtain additional information at their local VA or at www.volunteer. va.gov.

All of these suggestion and ideas can be used to introduce and guide new members to providing service to veterans, active military and their families. Many of these suggestions can be used for members who aren't near a VA facility or are homebound.

Any serious discrepancies will be directed to the DEC immediately. c. The second audit will be conducted at Department Convention. After completing the audit the committee will give a detailed, written report including the books that were detailed findings, audited, and any concerns at a time to be determined at Department Convention. If the changes to Standing Rule #5 are approved, the VA &R Committee recommends the approval of proposed changes to Standing Rule # 28 "c" which now reads:

Utilize leaders in your community - Contact government officials, religious leaders, and social service offices to ask about different programs in the community serving veterans.

• Once you have obtained contact information, reach out to the various organizations and ask them to identify their needs.

• Once you have identified the needs in your community, brainstorm different ways to meet these needs with your unit or American Legion Family.

Following is a list of ideas to get you started:

· Visit with veterans, and remember them on special occasions.

• Offer to drive veterans to doctor appointments.

American Legion Auxiliary Missouri Girls State Report

Greetings Members of the ALA Department of Missouri!

Things are really rolling along as we plan for the 80th session of American Legion Auxiliary Missouri Girls State. ALA MGS is excited about many new opportunities for this year's session to be held June 11-18th at Lindenwood University in St. Charles, Missouri! Not only will citizens experience a beautiful campus and its facilities, but the co-hosting experience with Missouri Boys State will bring a couple of joint events to participants of both groups! It is truly going to be a memorable experience for all. This year, the American Legion Auxiliary National Headquarters and ALA Missouri Girls State are also working with filmmakers Amanda McBaine and Jesse Moss of Mile End Films to produce a documentary film about the Girls State experience in June. They are the directors of the critically acclaimed, Emmy Awardwinning documentary Boys State (available on Apple TV+), and we are excited to be collaborating with them to tell this new story, about Girls State, with the 2022 participants. The goal of the film is to show how the Girls State experience equips young people to be full participants in our representative democracy.

We have reached 500 accepted delegates to the 2022 session and our numbers are still growing. We are fortunate to have the support of Auxiliary Units and Legion Posts across the state of Missouri, but also many high schools have gathered support for delegates to attend our program.

There are a couple of ways that you can continue to help the ALA MGS 2022 session! You can shop our Amazon Wishlist to provide additional supplies for the program at https://tinyurl.com/uzv2s7aw. These items will assist both ALA MGS citizens and staff. An additional way to help is to make a donation to the "Access Matters Campaign" to allow eligible ALA MGS or MBS citizens to ride a charter bus to the session without cost. We want to ensure all ALA MGS and MBS citizens have the ability to get to and from the program without having to drive more than 90 miles for any reason (getting to the program or getting to the bus sites). For more information on the Access Matters Campaign, visit the ALA MGS website. Directions to donate can also be located on the ALA MGS website. Lastly, we want you to visit our program this year and take in all of the excitement yourself! In the Legionette, you will see information about times you can visit. Sign up for one of the times and we will be happy to show you all the excitement that happens at ALA Missouri Girls State.

In July, the American Legion Auxiliary Missouri Girls State program will be proposing a fee increase at the Department Convention. The ALA MGS Committee, staff, and citizens would greatly appreciate your sincere support of this proposal. The last fee increase to \$300 was made in 2006. As you all know, costs have increased significantly in those 16 years. In 2021, our session averaged a cost of nearly \$340 per citizen prior to finalized costs. Upon exploring the 2022 options for hosting the ALA MGS session, we ultimately made the decision to move to Lindenwood University. UCM quoted ALA MGS \$185,000 to host the session for 2022 and Lindenwood University quoted \$200,000 with a lock-in rate for 5 years. Lindenwood University's proposal included items that-UCM had been billing-and would continue to billas a supplemental expense beyond the flat rate per person for holding the session. Thus, while the UCM bid was lower, the Lindenwood bid offered a greater value per dollar because we will not have as many supplemental costs.

With that being said, ALA MGS acknowledges that we will be required to use reserve funds again this year to be able to not only pay the bill to Lindenwood, but also to purchase and provide necessar materials for this year's session. Some of these items will include one-time purchases that can be used for multiple years like program signage. We will be able to provide more of a price breakdown at the time of Convention as we did in the fall of 2021. The proposed increase will be \$500 per citizen. This will allow ALA MGS to not only plan properly for utilizing funds, but also develop a significant scholarship base and enhance our presence at schools and communities that we have not been able to reach in the previous sessions. Questions about the fee increase can be directed to anyone on the committee or sent to director@ missourigirlsstate.org. While we know this cost increase will be hard for many American Legion Auxiliary Units across the Department, we know the importance of providing a premiere opportunity for our citizens to learn about participating in our representative democracy and the work that the American Legion Auxiliary does to benefit veterans and their families, and we know that the ALA Units across the Department will work together with schools and communities to gather funds necessary for this experience to be a true success. If we continue at our current sponsorship rate of \$300 per citizen, our reserve funds will be depleted, and we will not have anything remaining to pay for a session in 2023 or beyond.

We hope that you'll join us on the Lindenwood University campus this summer to see the amazing experience that you each help us provide year after year! I promise, there is not a better deal out there for young women to be involved as an active participant in the future of our community, state and nation. Thank you again for your continued support of ALA MGS 2022.

President Harry S. Truman

President Harry S Truman was the 33rd President of the United States and the first Legionnaire to hold this office. He was born May 8, 1884 in Lamar, MO. The "S" in his name has no significance.

Poor eyesight prevented Truman from participating in sports, but led him to his greatest passions, reading and music. He was proud that he had read every book in the Independence Public Library and was a fine piano player. Again, poor eyesight prevented him from attending West Point. This resulted in working a variety of jobs including farming, oil drilling and banking. He joined the Army and served in France and was discharged as a captain.

After leaving the military his haberdashery failed. Next his haberdashery failed. Next Truman started in politics. He won the race for County Judge in Jackson County. Later he became a Senator and held this position until President Franklin D. Roosevelt asked him to be his running mate in 1944. Fewer than 3 months serving as Vice President he became the 33rd President of the United States, following the sudden death of President Roosevelt.

Truman faced some complex issues, including dropping the atomic bomb in Japan to end WWII.

Domestic issues proved to be challenging, with labor unrest, The GI Bill, national health care and civil rights executive orders. These were some of the issues that caused him to become unpopular during his term, but today he is ranked 5th by historians behind Lincoln, Franklin D Roosevelt, Washington and Theodore Roosevelt. He had an instinctive feeling for what was right and what was expedient.

He was eligible to seek re-election, but declined. He retired and returned to Independence. He died December 26, 1972 at age 88. (Facts from the Biography of

Harry S Truman on the Internet.)

Parliamentary Tip #1

Meetings are more effective if Parliamentary Procedures are used. It is essential that the president have a prepared agenda to guide the meeting. An agenda is similar to a road map because it keeps you on track. When possible, distribute a copy of the agenda prior to the meeting. The Unit Handbook of the ALA provides a suggested order of business for agenda planning.

A sample agenda will include: call to order, advance colors, prayer, Pledge of Allegiance, national anthem, preamble, roll call of officers, reading and approval of previous minutes, treasurer's report and file for audit, reading of communication, reports, unfinished business, new business, announcements, adjournment and retirement of colors. Your unit may include other items, such as recognizing birthdays and anniversaries. It is thoughtful to ask if any member is ill.

The president should be familiar with the duties of her office as outlined in the Unit Handbook. She should start the meeting on time, preside impartially with tact and enthusiasm, assist other officers and chairmen when needed, and be generous with praise. It is also important to work hard for the unit and set an example for the members to participate in unit activities.
